SUBJECT: CropLife Canada members release initial Designated Seed Treatment Product Listing

CropLife Canada members have released the initial Designated Seed Treatment Product Listing as a component of the Accredited Seed Treatment Operation Standards implementation. The product listing has been identified by CropLife Canada members as seed treatment products that are to be used exclusively in commercial seed treatment operations that have successfully completed the Accredited Seed Treatment Operation Standards audit.

Effective January 01, 2018 only seed treatment operations that have successfully completed an audit will be eligible to receive shipments of designated seed treatment products from distributors or ag-retailers.

Background

The Accredited Seed Treatment Operation Standards were developed by CropLife Canada and its members in collaboration with industry and government stakeholders as a cooperative effort to safeguard the industry and proactively minimize the environmental, health and safety risks associated with the storage and application of seed treatment products at commercial seed treatment facilities in Canada. The standards were initially released in 2014 and re-issued in 2016.

The standards are designed to address and manage identified areas of potential risk that include spill prevention, emergency response preparedness, safe product handling/application, occupational safety and employee training, and education. Additionally, the standards incorporate existing National Fire Code, National Building Code, National Electrical Code and applicable occupational health and safety regulations.

In order to ensure that the standards are equitably applied and enforced, CropLife Canada and its members engage third party auditors to assess compliance. Those

operations that are not in compliance with the standards will be ineligible to receive designated seed treatment products as of January 01, 2018.

Subsequent Updates to Designated Seed Treatment Product Listing

The designated seed treatment product listing is at the discretion of the Canadian product registrant. The listing will be updated periodically and re-issued to seed treatment industry stakeholders as CropLife Canada members include registered seed treatment products on the designated seed treatment product listing.

Designated Seed Treatment Product List

CropLife Canada and its members are requiring that all commercial seed treatment operations (as defined by treating seed for sale or gain) successfully complete a 3rd party audit of their operation prior to **January 1, 2018**. This audit will help ensure strong environmental, health and safety practices are in place for the storage, handing and application of seed treatment products in Canada.

The following seed treatment product registrations have been identified by CropLife Canada members as products that are to be used exclusively in commercial seed treatment operations that have successfully completed an audit.

Effective January 01, 2018 only seed treatment operations that have successfully completed an Accredited Seed Treatment Operation Standards audit will be eligible to receive shipments of designated seed treatment products from Canadian distributors and ag-retailers.
